Re: Easter Holiday, Activity and Food Programme.

Dear Parent/Carer,

We would like to invite your child to attend an Easter Holiday, Activity and Food programme (HAF). The programme will run from 0900 to 1330 each day from Tuesday 6 April to Friday 9 April and will be based at Holsworthy Community College. It is open to eligible children in Years 5-11. All participants on the programme will receive a school meal. Children could be taking part in football, touch rugby, racket sports, athletics, cricket, indoor curling, archery and art activities. Okehampton Community and Recreation Association (OCRA) will be providing the activities, with support from members of staff from our secondary and primary schools.

Your child has been invited to attend this programme because they are in receipt of free school meals. We want all children to have a rich experience during the school holidays and are organising this programme so that young people in the Holsworthy area can have that fantastic opportunity. This programme is **free** for all participants and there is **NO CHARGE** to parents.

We will be using the risk assessment already in place at Holsworthy Community College and OCRA's own risk assessment to make sure that all activities are Covid-19 safe. The programme will be organised with the same protective measures as when the schools are operating during normal term time.

Although a full lunchtime meal is provided for your child, please could you send them with a water bottle and a snack to have at 11am. They will need to wear trainers and suitable clothes for PE activities, including a waterproof coat. The morning session will start at 9am, but children can arrive at the main gate of Holsworthy Community College from 8:50am. As it is the school holidays, school transport is not available. However, if transport is an issue because you live outside of Holsworthy, please let us know and we will try to help get your child to and from school.
